- Require the flexibility to repay the mortgage during the term of the product or make payments in excess of 10% in any one year.

4. Customers with characteristics of vulnerability

The products are designed for existing customers that are switching to a new scheme after maturity of an existing product. This is likely to include some customers with characteristics of vulnerability or who will experience vulnerability over time.
